ASSOCIATE DEAN FOR ACADEMIC AFFIARS VIKRAM AMAR published the 13th edition of his co-authored casebook. **Constitutional Law: Cases and** Materials (Thompson, 2009) (with Jonathan Varat and William Cohen), and also published an article, "When Avoiding Federal Questions Shouldn't Evade Federal Review: Michigan v. Long meets, and Trumps, Ashwander v. TVA," in the Green Bag 2d Journal (with ALAN **BROWNSTEIN**). In addition, he wrote several columns for **Findlaw.com**. He was interviewed by and quoted in National Public Radio, KQED, Minnesota Public Radio, the New York Times, the Wall Street Journal and the L.A. Times, among many other media outlets. He spoke at an event in San Francisco sponsored by the American Constitution Society, and another one put on by the California Political Attorneys Association. Along with CHRIS **ELMENDORF**, he has been serving as a legal and policy advisor to organizations leading the push for a California constitutional convention.

This summer, **ANUPAM CHANDER** presented "Youthful Indiscretion in the Internet Age" at the Privacy Law Scholars Conference at the University of California, Berkeley and at the "In the Age of Digital Convergence" conference at the University of Hong Kong. He traveled to China to participate in a conference on "The Copyright Industries and Intellectual Property" at the South China University of Technology Law School. In September, he presented a paper, "Googling Freedom," to the Northern California International Law Scholars, and a paper, "The Cosmopolitan President" at the UC Davis School of Law faculty workshop. (Cambridge University Press), edited by Heather Gerken, Guy Charles, and Michael Kang. His op-ed with Ethan Leib proposing a fallback procedure for solving budgetary deadlocks under divided government--"Budgets by the People, for the People"-appeared in the **New York Times** in July. In September, Chris gave a presentation at a Harvard Law School conference on National Human Rights Institutions. He is also serving as a legal and policy advisor to the Bay Area Council, which is leading the push for a California constitutional convention. He will be speaking on legal issues relating to constitutional revision at an upcoming conference in Sacramento, jointly sponsored by the Institute for Governmental Studies at UC Berkeley, the Center for the American West at Stanford University, and Sacramento State.

FLOYD FEENEY, in connection with the development of regulations by the State Auditor for creating the Citizens Redistricting Commission called for by last fall's Proposition 11, developed a definition of "impartial" and wrote a supporting paper entitled "The Concept of 'Impartiality' as Used in Proposition 11." Her paper, "Justice Deserts: Spatial Inequality and Indigent Defense" has been accepted for the Arizona Law Review's symposium on "Funding Justice." Lisa presented papers at the Law and Society Annual Meeting in Denver, and also organized two panels for this year's conference: "Land, Water, Poverty & Community at the Rural-Urban Interface" and "Drugs in the 21st Century: Socio-Legal Perspectives on Substance Abuse." She presented three papers at the Rural Sociological Society's Annual Meeting in July. Lisa presented a paper at LatCrit XIV in Washington, D.C. and was the featured speaker at the Women Lawyers of Sacramento September luncheon. She is Chair-Elect of the AALS Section on Women in Legal Education, and she served on an ad hoc subcommittee of the section to draft a proposal for a mid-year meeting program. Lisa was elected co-chair of the Rural Policy Interest Group of the Rural Sociological Society, and has completed her term as co-chair of the Rural Studies Interest Group.

CRUZ REYNOSO was recently awarded the State Bar of California's Bernard E. Witkin Medal to honor his "significant contributions to the quality of justice and legal scholarship" in the state. Established in 1993, the award honors "those legal giants who have altered the landscape of California jurisprudence." It was presented to Cruz, at the State Bar's annual meeting in San Diego.

DONNA SHESTOWSKY was awarded \$190,000 from the Law and Social Science division of the National Science Foundation (NSF) to fund her research on civil disputants' preferences for dispute resolution procedures. Her project will be the first-ever national longitudinal study of disputants' perceptions of court-connected dispute resolution. She was also quoted in the front-page article in the **Stockon Record** for her views on voir dire in the death penalty case of Melissa Huckaby. Professor Shestowsky also welcomed nearly 30 alums and friends of King Hall as judges of the third annual King Hall Negotiations Tournament in September. The competition offered a record number of student participants the chance to represent King Hall at future ABA competitions.

MADHAVI SUNDER presented a chapter on "Fair Culture" from her forthcoming book, iP: YouTube, MySpace, Our Culture, at the recent Access to Knowledge (A2K) Global Academy meeting at the Yale Law School in August. She and Anupam Chander completed the manuscript of a comic book on the life of civil rights hero Fred Korematsu. The comic book will be published by Carolina Academic Press, This summer Professor Sunder appeared on the Capital Public Radio program "Insight" to discuss trademark disputes brought by Sutter Home against smaller Amador County wineries that also use the Sutter name.

DENNIS VENTRY was cited by the United States Court of Appeals for the First Circuit Court in a landmark decision involving attorney-client privilege and work product protection as applied to a corporate taxpayer's tax materials. Moreover, the government had relied on two of his recent articles in its briefs and at oral argument. In addition, Dennis presented papers at the annual meeting for the Law and Society Association and the Jr. Tax Scholars Workshop, and will present his research at Duke University School of Law, Loyola Law, and Yokohama National University in Japan. Dennis also provided commentary on federal tax issues to the Wall Street Journal and Tax Notes, and he wrote an op-ed on California tax issues for the Sacramento Bee.
