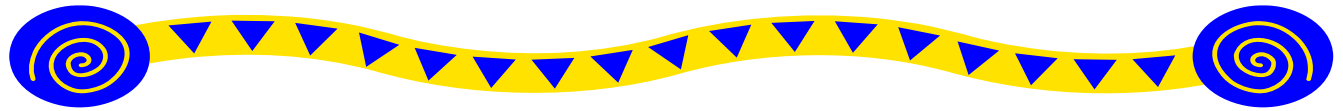

In September, **DIANE AMANN** presented (1) "Military and Civilian Justice in the United States and the Post-September 11 Military Commissions" in Paris as part of a military justice research project; and (2) a paper on military commissions at a RAND Corporation conference on "Terrorism, Global Security and the Law." She is the editor of *International Criminal, Transnational & Comparative Criminal Law*, an online journal launched by the Social Science Research Network. Diane was (1) named Co-Chair of ASIL West, a new project aimed at giving a regional presence to the American Society of International Law; and (2) elected

Secretary of the International Law Section of the Association of American Law Schools (AALS), and to the Executive Committee of the AALS National Security Law Section. **KCBS** radio (San Francisco) interviewed Diane on antiterrorism measures and military justice.

JACK AYER published **Bankruptcy Overview: Issues, Law, and Policies**, (5th edition, American Bankruptcy Institute).

In November, **ANDREA BJORKLUND** presented a paper on investment treaty arbitral decisions at a American Society of International Law conference in Bretton Woods, New Hampshire. In January, she participated in "The Future of Investment Agreements" conference at Boalt Hall.

ALAN BROWNSTEIN delivered his annual Supreme Court Review lecture to the Sacramento Chapter of the Federal Bar Association. He testified before the California Senate Judiciary Committee on the constitutionality of a proposed state constitutional amendment that would permit state funding for the repair and maintenance of California missions. In a program for USC undergraduates, Alan debated Eugene Volokh (UCLA) about whether the government should endorse religious beliefs. She is participating in a project of Stanford Law School and the Resources Legacy Fund, on the legal foundations of area-based ocean management off California.

conducted (1) a workshop on the implications of recent psychological research for the future of character evidence at Ohio State; and (2) spoke at a National College of District Attorneys seminar in Georgia.

KEVIN JOHNSON recently participated on a panel at the AALS annual meeting, and conferences at UC Berkeley (Boalt Hall), UNLV, and Sacramento State. He gave a series of presentations, including a keynote speech at Ithaca College, as part of Latino Heritage Month. Kevin also presented his new book at a faculty workshop at BYU law school. He published book reviews in the **American Journal of Legal History** and **Latino Studies**, and two pieces of commentary on the Legal Television Network website. This paper, which will appear in the journal *Research in Law and Economics*, received honorable mention in the AALS Contract Section Call for Papers and was a SSRN "Top Ten

Download." In January, Tom participated in a panel discussion on "Hurricane Katrina and Race" at the AALS annual meeting. He also spoke at a conference on progressive lawyering at Stanford. Tom was quoted in the *Sacramento Bee* and appeared on CNBC-TV to discuss corporate governance issues.
