FACULTY UPDATES

DIANE AMANN, teaching at UCLA this year, recently published articles and chapters in the International Journal of Constitutional Law, Global Governance and International Legal Theory, Hastings Journal of International and Comparative Law, and Encyclopedia of Genocide and Crimes Against Humanity.

Diane was a panelist on the International Law Section program at the 2005 AALS annual meeting and, last fall, made paper presentations at the University of Pennsylvania, Michigan, UCLA, and Washington law schools. She was named to the Board of Advisors of the National Institute of Military Justice and to the Executive Committee of the AALS International Law Section.

ANDREA BJORKLUND discussed international dispute resolution with



representatives of the California
Dried Fruit Association and its
European trading partners. In
October, she spoke on NAFTA at the
International Law Association's
International Law Weekend. Andrea
presented a paper at the
International Legal Studies
Roundtable at Boalt Hall.

Last fall, **CAROL BRUCH**, visiting at the UCLA Center on the Study of Women, attended a meeting of the Board of Editors of the **American**

Journal of Comparative Law. She presented a family law paper to the UCLA law faculty and submitted comments on a California Law Revision proposal concerning statutes of limitations in family law cases.
