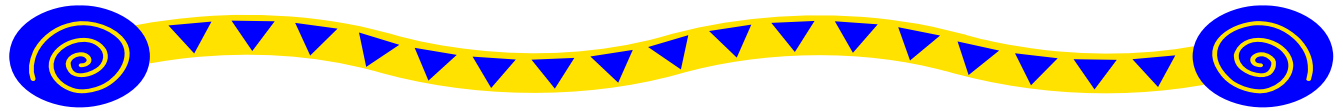

Georgetown Law Journal published **DIANE MARIE AMANN**'s "International Law and Rehnquist-Era Reversals." Diane was quoted in the *Star Telegram*, *Christian Science Monitor*, *Los Angeles Times*, and *Washington Post*. She also did radio interviews on *KCBS-San Francisco* and *Australian Broadcasting Company*.

JACK AYER is a co-author of "Chapter 11-101: The Essentials of Chapter 11 Practice," released by the **American Bankruptcy Institute**.

In June, Kluwer published **ANDREA BJORKLUND**'s co-authored book, **Investment Disputes Under NAFTA**. Andrea made three presentations at the International Law Association's biennial conference in Toronto.

CAROL BRUCH was recently elected to the International Academy of Comparative Law. **The Family Law Quarterly** published her article entitled "Sound Research or Wishful Thinking in Child Custody Law: Lessons from Relocation Law," in the summer 2006 issue.

In June, **JENNIFER CHACÓN** presented a paper at a conference in Paris on "Immigration, Liberty and Security from a Comparative Perspective." Her paper will be published in a forthcoming book. Jennifer was quoted in the *Los Angeles Times* on the Supreme Court's decision in *Fernandez-Vargas v. Gonzalez*.

In August, **ANUPAM CHANDER** presented his new paper, "Everyone's a Superhero," at the Intellectual Property Scholars Conference at Boalt Hall. The paper will appear in the *California Law Review*. In September, Anupam presented his new IP paper at the Law, Science and Technology

seminar at Stanford Law School. He along with **MADHAVI SUNDER** and **KEITH AOKI**, received a grant to write a comic book about civil rights legend Fred Korematsu. Anupam also was co-recipient of a grant to write about the naming of Davis's newest elementary school.

JOEL DOBRIS published "Undoing Repeal of the Rule Against Perpetuities: Federal and State Tools for Breaking Dynasty Trusts" in the **Cardozo Law Review** and published a letter to the editor of the **Financial Times** on the behavioral economics aspects of charitable giving under the Internal Revenue Code.

HOLLY DOREMUS published "Species Coverage in Multispecies Habitat Conservation Plans: Where's the Science?," in **BioScience**. Holly is part of an interdisciplinary UC Davis team that was recently awarded a \$400,000 grant to develop new hydropower licensing in the Sierra Nevadas.

Bill's new book **Deporting Our Souls--Values, Morality and Immigration Policy** (Cambridge University Press) will be published this month.

Davis Law Review**.

Ed also published commentary in the **National Law Journal**. He lectured on expert testimony to Iowa prosecutors and spoke about cross-examination to the National Association of Criminal Defense Lawyers.

In July, **ELIZABETH JOH** presented a paper at the Law and Society 2006 annual meeting. In October, she made a presentation on the future of "abandoned DNA" at Boalt Hall's Center for the Study of Law and Society.

Madhavi, Anupam, and **KEITH AOKI** were awarded a grant to pen a comic book about Fred Korematsu. Anupam and Madhavi, along with

King Hall 3L Raymond Kim, received a grant to create a documentary chronicling the personal internment experiences of Davis residents.
