He was the luncheon speaker for the annual "Operation Protect and Defend" Luncheon in Sacramento. He conducted numerous media interviews, and

She also gave presentations at Chicago-Kent College of Law, UC Berkeley's Energy and Resources Group, the Center for Progressive Reform winter meeting, and the California Native Plant Society Conservation Conference.

Lisa recently was interviewed by the **Fort Worth** Star Telegram about regulation of the fertility industry and by KDVS about ethical and legal issues arising from the HINI flu outbreak.

In March, he presented a paper on "The Intersection of Race and Class in U.S. Immigration Law and Enforcement" at the Center for the Study of Race, Ethnicity and Politics at UCLA. In recent months he has presented research as part of the Western Center for Agricultural Health & Safety seminar series at UC Davis, a USF Law Review Symposium, and a conference on diversity at Sacramento City College.
